Is TTG a dumping duty on solar panels?

The Directorate General of Trade Remedies (DGTR) has recommended an anti-dumping duty on imports of Textured Tempered Glass (TTG) from China and Vietnam. Commonly used in solar panels, TTG is also referred to as Solar Glass, Low Iron Solar Glass, Solar PV Glass, High Transmission Photovoltaic Glass, and Tempered Low Iron Patterned Solar Glass.

Should India impose anti-dumping duty on solar glass imports from China and Vietnam?

India's Directorate General of Trade Remedies (DGTR) has recommended an anti-dumping duty on solar glass imports from China and Vietnam after its investigation concluded that imports from these countries are undercutting the prices of the domestic industry.

From pv magazine India India has imposed antidumping duties on textured toughened (tempered) glass in solar panels and solar thermal products from China and Vietnam for a period of six months, starting Dec. 4, 2024.

The imposition of anti-dumping duties on Chinese photovoltaic solar glass enterprises exported to the Indian market has had a certain impact, increasing the cost of sales and competitive pressure on Chinese enterprises in the Indian market.
